



## Required Form for Firearms Purchases



**The following agreement applies to all current and future firearms manufacturer brands at Kroll International**

### 2018 Agreement for Kroll International Dealers Selling Firearms via the Individual Officer Program (IOP) for First Responders

It should be understood that firearms are offered at Kroll International at discounted pricing and, in most cases, with additional accessories at no additional cost, via each manufacturer's Individual Officer Program (IOP) or Armed Professional Program (APP). As such, it is imperative that Kroll International Dealers understand that the sale of these firearms are intended for purchase by the First Responder community ONLY, and thus adhere to this requirement. **Failure to adhere to the program will result in the loss of the program for your account through Kroll International.**

For First Responder firearms sales, a copy of the qualifying credentials or business card must be kept on file with one of the following: ATF Form 4473 (Firearms Transaction Record Part 1 – Over-the-counter), State transfer form, or bill of sale. Below is a list of what firearms manufacturers, as well as Kroll International LLC, define as First Responder personnel. Please understand that this list is not all-inclusive due to variations in individual communities throughout the United States that should be considered prior to sale.

#### First Responders include, but are not limited to:

- All sworn Law Enforcement (LE) officers, including State, County, and Local
- All Federal LE officers (FBI, US Marshal, DEA, etc.)
- All Retired LE officers, including Federal, State, County, and Local
- All Corrections Officers, including Parole and Probation Officers
- State-licensed Security Companies (e.g., Loomis Fargo, RAM Security, Securitas, etc.)
- State and local-licensed Security Officers
- Active military personnel – all branches
- National Guard personnel – all branches
- Military Reserve personnel – all branches
- Disabled military personnel (in any capacity)
- Officially retired military veterans
- Licensed Paramedics and Emergency Medical Technicians (EMTs)
- Firefighters (including volunteers)
- Additional fire personnel, including Fire Marshalls and Arson Detectives
- First Responders
- County Coroners
- All Transportation Security Administration (TSA) employees
- Commercial Pilot License holders, regardless of class
- Federal Flight Deck Officers
- Court Judges and Court Officers
- District Attorneys and Deputy District Attorneys
- NRA Certified Firearms Instructors
- LE Academy or College students with proof of enrollment in a Criminal Justice Program

**Note: Official identification/Credentials is/are required to verify a qualified purchaser**

Ultimately, once you have possession of the firearms you have purchased from Kroll International, we understand that you are able to sell these products at your discretion, provided all pertinent background checks are valid and the purchaser is legally allowed to purchase the firearm(s) in adherence to all applicable federal, state and local laws/requirements. However, as part of this agreement, Kroll International requires that you also adhere to the First Responder guidelines stated above. All firearms purchased through Kroll International under the manufacturer's Individual Officer Program (IOP) or Armed Personnel Program (APP) must be destined for First Responders.

**As a reminder, failure to adhere to the program outlined in this document will result in the loss in of the program for your account through Kroll International.**
