<b>INHALATION:</b>

<b>SECTION 5 - FIRE FIGHTING MEASURES</b>								
<b>GENERAL HAZARDS:</b> Flash Point: 94°C (201°F) PMCC								
<b>EXTINGUISHING MEDIA:</b> Carbon Dioxide, Dry Chemical, Foam.								
<b>FIRE FIGHTING PROCEDURES:</b> Firefighters should wear NIOSH approved, positive pressure, self-contained breathing apparatus to avoid exposure from decomposition products. Proper eye and skin protection should be used. If a spill has not ignited, use water spray to disperse vapors and keep container cool.								
<b>UNUSUAL FIRE AND EXPLOSION HAZARDS:</b> After ignition, the use of water can scatter the liquid thereby possibly spreading the fire. Ignition may also produce dense black smoke.

<b>SECTION 6 - ACCIDENTAL RELEASE MEASURES</b>								
<b>STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:</b> For small spills, vacuum into waste containers or absorb with dry sand or absorbent cloth. For large spills immediately evacuate the area and shut off potential ignition sources. Only personnel equipped with proper respiratory and skin/eye protection should be permitted in the area. Dike the area to contain the spill. Take precautions as necessary to prevent contamination of ground or surface waters. Recover with a wet vacuum or absorb spilled material in sawdust or vermiculite and sweep into closed containers for disposal. After all visible traces have been removed, thoroughly wet vacuum area again. DO NOT FLUSH INTO SEWER.

<b>PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE:</b> Keep away from open flame or other ignition sources. Do not store above 120°F. Maintain adequate ventilation and keep from children. Note that some vapors are heavier than air and can displace air in low areas or confined spaces such as pits or tanks. Do not enter those areas where large quantities of vapors are suspected of collecting until exchanging the air or using special breathing apparatus with an observer present for possible assistance.
